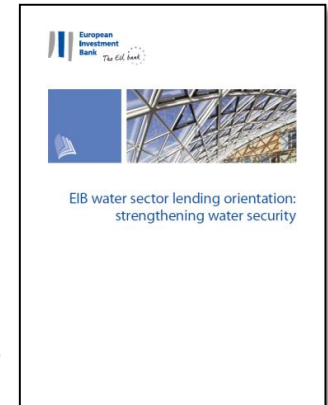

EIB Activity in the water sector

- Largest source of financing to the sector
- **Over EUR 60 Bn deployed to date**, 90% in the EU
- Lending to the water sector = 5% of EIB's total lending
- Lending covers the whole water cycle (water resources, water supply, sanitation, flood protection)
- New Water Sector Lending Orientation (Dec 2017) – focus on **strengthening water security**
- Key strategic areas: support to water utilities including also smaller ones, Industrial Water Management and Innovation



EIB Activity in the urban development sector

- **Over EUR 22 Bn** in urban lending in 2017
- EIB has lent directly to over 150 of the 930 EU cities with a population above 75,000
- Objectives: urban regeneration, social inclusion, climate action, enhanced community resilience, smarter development
- A new advisory instrument called **URBIS** (Urban Investment Support)
- **EU Urban Agenda** under the Pact of Amsterdam
- SDG 11

EIB supporting the transition to a circular economy

- CE is strongly aligned with **EIB policy objectives** (Innovation, Environment, SME, Climate action)
- EIB helps **bridge financing gaps** and **catalyse investments** through EFSI, InnovFin and other risk sharing instruments
- EIB can **advise** on CE project structuring/financing
- EIB water projects support energy recovery, reuse of treated wastewater and recycling of nutrients from sewage sludge into high quality fertiliser
- EIB promotes water efficiency, water stewardship and innovation



Adaptation to Climate Change

- Too much and too little water...
- Water/Energy/Food/Land Use
- Climate Risk and Vulnerability Assessment
- Changing urban landscapes (NZEBS, smart mobility, green infrastructure, permeable paving materials, land-use planning...)
- 1/3 of urban lending to **Climate Action**
